The Borough had filed a bond of \$300 conditioned for repayment of \$150 that had been granted the Borough by the County Commissioners, plus any costs of suit, in case the auditors appointed by the court would disapprove the grant.
12/10/1937		Accepting an offer of the United Telephone Company to have in its exchange and to operate a central station transmitter with code wheels for sounding a fire alarm device in the Borough of Gettysburg and stating the terms of such offer and acceptance.
9/7/1938		Providing for a dumping ground for garbage and refuse, authorizing a contract therefor, and providing for payment. The contract, with Paul L. and Ella N. Plank, was for 5 years, to allow the Borough, its citizens and its licensees the privilege of dumping garbage and refuse.
1009-83	7/12/1983	Authorizing and directing entry into a reciprocal police aid and assistance agreement with Gettysburg National Military Park.
1183-96	11/12/1996	Adopting and approving an amendment to the Article of Incorporation of Gettysburg Area Industrial Development Authority to extend the corporate life of such Authority.
1195-97	9/8/1997	Authorizing the Borough of Gettysburg, Adams County, Pennsylvania, to join with other political subdivisions as a member of the Capital Region Insurance Trust, to enter into an intergovernmental agreement for the purpose of joining the Trust and to participate as a member of the Trust.
1196-97	9/8/1997	Authorizing the Borough of Gettysburg, Adams County, Pennsylvania, to join with other political subdivisions as a settlor of the Pennsylvania Local Government Investment Trust for the purpose of purchasing shares of the Trust.
